In consideration of payment in the amount of CAD \$250.00 (by cash or by certified cheque/money order) payable to "Keeshond Rescue of Ontario" as a non-refundable donation, and in consideration of the adoption of the Keeshond (hereinafter, the 'Dog') known as

(the receipt and sufficiency of which is hereby acknowledged), the 'Adopter' hereby releases, discharges and covenants to hold harmless and indemnify KRO, its members, officers, employees, and agents from all claims, demands, actions, judgments and executions which the undersigned, their heirs, executors, administrators or assign ever had, has now, or may have or claim arising out of the adoption of the Dog noted herein, including any claims for negligence.

The 'Adopter' hereby acknowledges and declares that no representations or warranties of any type whatsoever have been made by KRO, its officers, members, employees, or agents with respect to the Dog adopted pursuant to this Agreement.

### 3. Terms

#### **KRO and the 'Adopter' hereby agree to the following terms:**

##### **a. Medical Condition and Records:**

KRO shall supply the 'Adopter' with a copy of all current and available medical records of the Dog as of the time of adoption. KRO and the 'Adopter' agree the KRO makes this adoption placement with no warranty as to the physical condition or temperament of the Dog, and that the 'Adopter' accepts the Dog as is, with all defects either evident or unknown, and assumes full risk for this Dog from the date of this Agreement. In most cases of dogs in rescue, early health records prior to rescue are unknown, and the 'Adopter' warrants that s/he has understood this fact. KRO warrants that the Dog has been tested for heartworm and that the results of the test are negative. The 'Adopter' agrees to provide the Dog with heartworm prevention medication and any medically recommended steps for flea and/or tick prevention as prescribed for the area in which the 'Adopter' resides. KRO warrants that the Dog has received the following vaccinations:

1. Rabies
2. Distemper
3. Bordatella
4. Leptospirosis

KRO warrants that the Dog has been neutered/spayed.

The 'Adopter' agrees to allow KRO access to future veterinary records of the Dog upon request. KRO has provided all veterinary care deemed necessary during the fostering of this Dog; any and all future vet costs for this Dog are the sole responsibility of the 'Adopter'.

##### **b. Microchip Registration:**

KRO shall contact PetWatch to transfer primary contact information from the KRO foster home to the 'Adopter' within forty-eight hours of the adoption. The 'Adopter' agrees that KRO shall remain the emergency contact with PetWatch for this Dog.

##### **c. Collar:**

KRO shall provide a soft-slip fabric collar with the Dog; the 'Adopter' agrees that the Dog will wear this or another such collar with the current rabies tag, the microchip ID tag and an ID tag with the 'Adopter' contact information available on it, at all times.

##### **d. Return:**

In the event that the 'Adopter' no longer wishes to maintain ownership of the Dog adopted pursuant to this Agreement, or if the 'Adopter' fails to comply with the terms and conditions of this Agreement, the Dog shall forthwith be returned to KRO.

##### **e. Transfer of Ownership:**

Ownership of the Dog adopted pursuant to this Agreement may not be transferred to any other person, firm, corporation, or organisation for any reason whatsoever, without consultation and prior written consent of KRO which retains the Right of Return under d. above.

##### **f. Post-Adoption Follow-up:**

The 'Adopter' agrees to keep in touch with KRO throughout the life of the Dog to report on the progress of the adopted Dog. It is understood that KRO may contact the 'Adopter' on a regular basis to follow the progress of the adopted Dog. It is understood and agreed upon that a representative of KRO will be permitted to examine the Dog in person with reasonable notice at a time mutually convenient to both the 'Adopter' and KRO at any time in the future. KRO offers its services for further information on the Keeshond breed and its characteristics, and encourages the 'Adopter' to contact them with any questions that might arise.

##### **g. Notifications:**

The 'Adopter' agrees to notify KRO in case of an email or postal address change or telephone number change within 21 calendar days of the change. The 'Adopter' agrees to notify KRO by telephone, email or in writing within 3 calendar days if the Dog should be lost, stolen or deceased.
